 - a. ICIP Gamerco Water and Sanitation District The wish list has been submitted to the state and are awaiting the Senators decision.
 - Water Shut Off Protocol and Procedures Currently, the residents are given a fifteen (15) day notice prior to having their water shut off for delinquent accounts. The accounting company has a full handle on who gets disconnected and who gets their water restored. The Gamerco office has no control of those actions. That is adequate notice as other utility companies give a three (3) day notice. Restoral will be completed if the customer has paid their bill in full and we get an order from Glenda to restore services.
 - c. Resolution to remove Magdalena Garcia as the Gamerco Water and Sanitation District Secretary. Ms. Garcia has been terminated from her position at GWSD and this item was a recap from the previous meeting.
 - d. Gamerco Water and Sanitation District Employee Raise of 6%. The \$1 raise for all the employees has been completed. The GWSD has landed a very reliable, dependable and productive crew. There is currently a trash truck driver, foreman, two laborers and the secretary that are employed at the Gamerco office.
 - e. Review and adjust sewer rate. Salvador will follow up with this item.
 - f. New Trash Truck This item is tabled awaiting the senator's decision.
